We wish to highlight the ADA's call to action that was distributed earlier today. That call to action may be found <u>here</u> and is included within the report below.

As the US Senate works towards another stimulus package this afternoon and evening it would be good to have voices heard to ensure dentists and dentistry are not forgotten and begin to be placed in the forefront with other healthcare providers undergoing similar distress in their practices. Please look at the call to action and see if it would ultimately benefit your supported offices and businesses. Although some of the relief references small businesses, with 50 or fewer employees, many of the other provisions could help dental offices get through the current crisis. If you believe this call to action could help please feel free to forward it on to your supported and affiliated offices. We have also included the ADA's COVID Coding and Billing Guidance which was distributed earlier today.

STATE DENTAL BOARD / STATE DENTAL ASSOCIATION UPDATES

Please be advised, the States of <u>Alabama</u>, <u>Alaska</u>, <u>Arizona</u>, <u>Colorado</u>, <u>Kentucky</u>, <u>Louisiana</u>, <u>Minnesota</u>, <u>Mississippi</u>, <u>Ohio</u>, <u>Oregon</u>, and <u>Washington</u> are prohibiting non-essential and non-emergent surgeries or procedures. We also wish to highlight that the States of <u>California</u>, <u>Illinois</u>, and <u>New York</u> have issued modified shelter in place orders. Effectively, these orders direct that essential services such as gas stations, pharmacies, grocery stores, banks, and laundromats will remain open. Similarly, the order close restaurants, bars, nightclubs, entertainment venues, gyms, public gatherings, and convention centers.

FISCAL NOTE – State Legislative COVID-19 Initiatives

At present, the ADSO is currently tracking 194 legislative initiatives across 25 states, the District of Columbia and the United States Congress.

Relevant Pending Legislation:

AZ SB 1690

Establishes the Crisis Contingency and Safety Net Fund and permits the fund to be discharged by the Governor in a state of emergency for (1) Housing Assistance, (2) to secure services for the Homeless, (3) Economic Assistance for small business with less than 50 employees, and (4) Food Bank Operations,

AZ SB 1694

Permits the department of economic security to implement alternative benefit eligibility and employer contribution requirements for the federal-state unemployment insurance program established pursuant to title, consistent with the federal guidance issued by the United States department of labor through unemployment insurance program letter number 10-20, for individuals and employers who are affected by a declaration of emergency related to the coronavirus disease 2019. The department may adopt rules necessary to administer this section.

<u>US S 3548</u>

Senate McConnell's proposed legislation of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"). The analysis is lengthy and for the sake of brevity is attached to this report as "CARES Act Analysis".

The Senate Democrats have also release initial drafts of their most recent economic bailout plan. That bill is attached as "Save America's Main Street Act of 2020". A brief analysis of the proposal is available <u>here</u>.

Relevant Enacted Legislation:

MD HB 1663: Authorizes the Governor for the duration of the emergency to:

- Prohibit cost-sharing by carriers for testing;
- Order Dept. of Health to cover the cost of testing if costs are not otherwise paid for by a carrier or third party;
- Require carriers and Medical Assistance Program to cover the cost of immunization for COVID-19;
- Waive telehealth protocols;
- Order Dept. of Health to reimburse telehealth services provided to a patient if covered under Medical Assistance Program, providing by a participating health care provider, and authorized under the provider's scope;
- Prohibit retailers from increasing the sale or rental price of a good or service to a price that increases his profit by more than 10% for food, fuel, water and ice, medicine, medical supplies and equipment, cleaning products, building supplies and equipment, energy sources, and storage space;
- Prohibit any employer from terminating an employee solely on the basis that the employee has been required to be isolated or quarantined; and
- Order the Dept. of Health to authorize an alternative workweek for an employee of a health facility owned by the Dept. and open 24/7 and who is subject to the MOU with the American Federation of Teachers.

If Governor orders an alternative workweek, it may allow an employee to work hours or shifts not typical for State employees and work less than 40 hours per week. An employee authorized to work an alternative workweek shall be considered a full-time State employee and entitled to overtime compensation.

Authorizes the Secretary of Labor to determine that an individual is eligible for unemployment benefits if:

- the individual's employer temporarily ceases operations due to COVID-19, preventing employees from coming to work;
- the individual is quarantined with the expectation of returning to work after the quarantine is over; or
- the individual leaves employment due to the risk of exposure or infection or to care for a family member due to the virus.

MD SB 1080:

Authorizes the Governor to take certain actions in a state of emergency, including prohibiting cost-sharing by carriers for disease testing, immunization and any associated costs; retailers from increasing the sale or rental price of any good or service by more than 10%; and employers from terminating quarantined or isolated employees

SC H 4014:

From the Fiscal Year 2018-2019 Contingency Reserve Fund, there is appropriated \$45,000,000 to the Executive Budget Office for use by the Department of Health and Environmental Control for the coordination of the state's public health preparedness and response to the COVID-19 virus.
